Kathe Livengood spent her life helping others and giving back to our community in countless ways. Her passion and commitment for helping others raised thousands of dollars to assist the elderly, children, injured and disabled and those battling with cancer. We lost Kathee suddenly in 2012 to an aggressive form of lung cancer. Because of her giving spirit and leadership, a group of women came together to honor her legacy by helping women improve their lives through education.

Working with the Grapevine United Charities, the KL Scholarship Fund was created in 2013. Scholarships are granted twice a year (June and December). Working with local health and service organizations, applicants are pre-screened to identify need and probability of future success. To date, the KL Memorial Scholarship fund has helped 63 women improve their lives through education and awarded over \$125,000 in scholarships.
